#### DENVER UNION STATION CODE OF CONDUCT

### In order to help ensure a pleasant and safe environment, we ask that all visitors refrain from the following:

- 1. Occupying more than one seat, sitting or laying on the floors or other non-seating surfaces, or standing on benches, chairs or other furniture
- 2. Moving any furniture or unplugging any lamps
- 3. Sleeping or dozing during regular business hours
- 4. Using obscene or abusive language or gestures, making unreasonable noise, including playing music
- 5. Impairing pedestrian or vehicle movements
- 6. Use of skateboards, bicycles, skate shoes, recreational scooters, or similar devices. Only approved ADA devices are authorized.
- 7. Defacing or damaging any property
- 8. Conducting commercial activity without permission, unauthorized solicitation or distribution of flyers
- 9. Smoking and/or vaping in non-designated areas
- **10.** Littering, causing unnecessary mess, or removing objects from trash receptacles
- **11.** Using sinks, water fountains, restrooms or common areas to bathe, shave, groom, brush teeth or clean clothes
- 12. Offering baggage or transportation assistance
- **13.** Expelling bodily waste in any area other than the appropriate use of restroom facilities
- 14. Entering restricted areas
- **15.** Endangering the safety of others, engaging in fighting, threatening another person and/or harrassment

#### DENVER UNION STATION CODE OF CONDUCT

- Wearing masks or make-up to disguise identity, except as specifically authorized
- 17. Placing feet and/or luggage on the furniture and fixtures
- 18. Having outside food or beverage in the building
- 19. Allowing animals on furniture or in a person's lap or within 20 feet of any food service establishment unless otherwise permitted by law
- 20. Entering the building barefoot or removing shoes while inside
- 21. Using flash photography or a tripod unless otherwise permitted
- **22.** Having excessive bags and/or other personal property without valid Amtrak fare or being a current Crawford Hotel guest
- 23. Leaving personal property unattended. Unattended property will be subject to search and/or confiscation
- 24. Occupying the common area of the Great Hall for more than 30 minutes without valid Amtrak fare or being a patron of Denver Union Station or current Crawford Hotel guest
- **25.** Causing safety hazards including tripping/slipping hazards and pathway obstruction or bringing balloons into the building
- **26.** Personal grooming within any food service area or changing clothes in public areas
- **27.** Removing alcoholic beverages from the service area where original purchase was made
- **28.** Carrying or possessing any unlawful weapon or instrument that could be used as a weapon
- **29.** Fouling any furniture or property, causing disruptive odor, or indecent exposure

Restrooms and seating within the common areas of the Great Hall are reserved for patrons of Denver Union Station, Amtrak, and the Crawford Hotel only. All visitors must comply with local and federal laws and ordinances.
